We have a staff of about 1,500 and an operating budget of nearly \$250 million. The Court's Judges, Commissioners and employees are recognized for their high standards of achievement, integrity, and diversity. The Court is committed to ensuring equal access to court services and enhancing public confidence in the court system.

### **EXAMPLES OF DUTIES**

Superior Court Commissioners perform subordinate judicial duties as authorized by law, including conducting hearings, making findings, and issuing orders in Civil, Criminal, Family, Child Support, Juvenile, Small Claims, and Traffic matters. Upon agreement of the parties, Superior Court Commissioners may serve as Temporary Judges. Superior Court Commissioners may be assigned to any Orange County Superior Court location. Calendar assignments may include:

- Traffic: conduct arraignments and trials.
- Small claims and other civil matters, including unlawful detainers: hear motions and conduct trials.
- Criminal: conduct arraignments, handle a pre-trial calendar, and preside over misdemeanor or infraction trials.
- Family Law: conduct child support calendars, including OSC's and contempt.
- Juvenile Delinquency: conduct detention hearings, pre-trials, jurisdictional hearings, and probation violation hearings.

• Juvenile Dependency: conduct initial detention hearings, ex parties, law and motion, dispositional hearings, and permanency planning for long-term foster care, guardianship, and adoption.

## MINIMUM QUALIFICATIONS

Candidates must be active members in good standing with the State Bar of California and must have been admitted to practice law in California for at least ten (10) years. Persons seeking appointment as a Superior Court Commissioner must demonstrate relevant legal experience as deemed sufficient by the judges of the Court. Superior Court Commissioners may not engage in the private practice of law.

### **APPLICATION PROCESS**

An online application, along with the supplemental questions serving as the Orange County Superior Court Commissioner Personal Data Questionnaire and a professional resume must be submitted by 5:00 p.m. PST on Friday, June 9, 2023. No paper applications will be accepted, only online applications will only be accepted.

### **SELECTION PROCESS**

Judges serving on the Court's Executive Committee will evaluate the applications. The most qualified applicants will be invited to participate in interviews with Judges of the Orange County Superior Court. Final selection will be made by a majority of the Judges of the Orange County Superior Court.

Factors that may be considered in evaluating candidates include knowledge of legal principles, statutes, and case law; analytical and oral/written communication skills; integrity; and temperament.

#### **BACKGROUND CHECK**

A thorough background check will be conducted, including but not limited to work experience, education, driving record, criminal record, involvement in civil or other litigation, and financial/credit information.

#### **ELIGIBLE LIST**

This recruitment will be used to establish an eligible list for current and future needs. The eligible list will remain active until the list is exhausted or a new recruitment opens.
